The buyer acknowledges that Lhasa Apsos may live 12-14 years or more. In signing this contract, the buyer indicates his/her understanding that he/she is taking full responsibility for all aspects, financial and otherwise, for this Lhasa Apso's life-long health, comfort, and safety. The buyer agrees to

- Provide proper maintenance and emergency health care, including spaying or neutering prior to age 6 months (if this Lhasa Apso is purchased as a companion pet).
- Provide plenty of socialization and training classes to assure the dog will not become the dominant member of the household.
- Keep the dog on leash when it is not in a fenced area.
- Be responsible for all liability in case of accidents while the dog is in his/her care.
- Contact Joyslyn's if there is ever a need to place the dog in another home. Joyslyn's will either take the dog back or help the buyer find a new home for the dog if necessary. Transportation fees are the responsibility of the owner. In the event that Joyslyn's is no longer available to take the dog, the Lhasa Apso may be turned over to the national Lhasa Apso Rescue organization. If on his/her own the buyer has found a new home for the dog, he/she will notify Joyslyn's of that fact. At no time will the buyer turn this dog over to any humane society, animal shelter, commercial breeders, or brokers.

If this Lhasa Apso is being sold as a show/breeding potential dog:

- The buyer agrees to make every possible attempt to finish the dog to an AKC Championship title. These attempts include proper socialization, training, grooming, health care, and handling to prepare the dog for competition. Joyslyn's does not guarantee a puppy sold as a show prospect will become a champion. Too many variables (i.e., proper socialization, training, grooming, health care, and handling to prepare the dog for competition, etc.) are the responsibility of the buyer.
- The buyer agrees not to sell any puppies from this Lhasa Apso to puppy mills, commercial breeders, brokers, or pet store/retail sellers.
- The buyer agrees to use the kennel name prefix **Joyslyn** or **Joyslyn's** when registering this Lhasa Apso with AKC. The buyer may also add his/her own kennel name to the registered name as long as the Joyslyn prefix appears first in the name.

If this dog does not appear to be show/breeding quality by the age of 9 months, one of three options listed below could be decided upon between the buyer and seller.

- (1) The buyer can keep the dog if he/she desires.
- (2) If the buyer does not want to keep the dog and if Joyslyn's wants the puppy back, then the buyer would send the puppy back and receive a replacement puppy. Transportation charges are the responsibility of the buyer.
- (3) If neither the buyer nor Joyslyn's wants to keep the dog, the buyer can sell the dog to a pet home as long as the AKC registration certificate is withheld until proof of spaying/neutering is provided by the new owners. Money from the sale would belong to the buyer. The buyer would not receive a replacement dog from Joyslyn's. At no time will the buyer sell or give this dog to a puppy mill or commercial breeder, abandon this dog, or turn it over to an animal shelter.

Health Guarantee

For provisions of this guarantee to be in full effect, the dog identified above must be taken to a licensed veterinarian (of the purchaser's choice) for an initial exam within 5 business days of leaving the Johanson household. If a health problem is discovered at that examination, Joyslyn's should be notified immediately. Full refund will be given if the request is accompanied by a veterinarian's verification of disease or defect present at the time of sale. Within 5 days of the exam, the puppy can be returned to Joyslyn's for a full refund or for a replacement puppy, if one is available. *Transportation charges for return of the puppy and delivery of a replacement are the buyer's responsibility.* If the puppy is kept, Joyslyn's no longer assumes any responsibility for the dog's health, nutrition, coat care, temperament, or training, other than what is stated below.

This guarantee does not cover veterinary expenses. This guarantee is not transferable. This guarantee covers only those diseases listed below. Refunds or replacements are given for no other health-related problems.

Joyslyn's guarantees the puppy identified above against the following diseases until the puppy is 24 months old:

(1) Von Willebrand's Disease, (2) Autoimmune Hemolytic Anemia, (3) Epilepsy, (4) Hydrocephalus, (5) Renal Dysplasia.

Joyslyn's does not give monetary refunds but agrees to replace the dog if he/she dies as a result of one of the above named diseases. However, Joyslyn's will not replace a dog if we were not advised of him/her being ill or of the necessity of him/her being euthanized beforehand. Contact may be by phone, email, or letter.

Upon the dog's death as a result of one of the diseases referred to above, Joyslyn's must be notified by letter and accompanying documentation proving one of those diseases caused the dog's death. The documentation, from a licensed veterinarian, may include photocopies of tests, x-rays, and autopsy results. *Notification must include a copy of this guarantee.* Joyslyn's is responsible for providing a replacement ONLY IF an autopsy and appropriate pathological examinations are performed, at purchaser's expense, to confirm the diagnosis. Any veterinarian's diagnosis shall be subject to confirmation by a veterinarian chosen by Joyslyn's. Should Joyslyn's veterinarian not concur with the diagnosis, the matter shall be presented to a third veterinarian mutually agreed upon by the seller and the purchaser.

The buyer recognizes that since Joyslyn's has only two or three litters each year, replacement puppies are not always immediately available and there may be delays in replacing the dog. It is the buyer's responsibility to pay any transportation charges to get the replacement puppy to his/her new home.

Joyslyn's is not responsible for any accident or injuries to the dog while he/she is owned by or in possession of the buyer. This guarantee does not cover injuries or illness caused by accidents, neglect, or abuse, including improper diet and improper grooming and coat care. The buyer must provide adequate veterinary care, including but not limited to, annual checkups, vaccinations, and heartworm tests. Buyers must keep all vaccinations current and administer heartworm preventative as prescribed by a veterinarian. Failure to do so voids the guarantee. Joyslyn's suggests the buyer keep this guarantee in a file with receipts from all veterinary visits until the dog is two years old and the guarantee is no longer in effect.

I (We) understand that Joyslyn's will withhold AKC registration papers until proof of the spaying/neutering is received. I (We) understand that Joyslyn's health guarantee is void if the spaying/neutering is not done BEFORE the dog is 6 months old. This Lhasa Apso should be neutered on or before _____.
